# First Families of Defiance County and Centennial Families

### <u>Defiance County First</u> Families

If you can prove your ancestor resided in Defiance County before January 1846, your ancestor can be classified as a "Pioneer." If he or she lived here between January 1846 and December



1860, that ancestor can be classified as a "Settler." To prove your lineage back to your ancestor, you may use birth records, death records, marriage licenses, census records, Bible records, and other primary or supportive secondary records.

The application fee is \$15.00 which covers as many ancestors as you can prove and also covers your membership pin. You must be a member of the Defiance County Chapter OGS. This membership may be paid at the same time as your application fee is paid. The cutoff date is August 1st of the year in which you apply. ### **Defiance County Centennial Families**

To acknowledge families which have been in Defiance County for 100 years or more, our chapter has established a centennial recognition program. Just one item of proof showing that a family member was here in 1918 or before is needed to register a family. Upon registration, a certificate will be sent from the chapter. ### **DCGS Honors 1st Family Recipients**

Five Families totaling 12 individuals received their First Family certificates during a reception at the Oct. 25 meeting of the Defiance County Genealogy Society. Nickolas Wilhelm, of Fort Wayne, received the award for eight of his early ancestors with surnames Wilhelm, Strahle, Fischaess, Eckert, and Harriger, who all resided in Washington Township. Nick's sisters Paula Wilhelm Oglesby and Mary Wilhelm Gardner also received the award. Both currently reside in California and were unable to attend.

Patricia Rosaline Campbell, a resident of Santa Ana, California, received the award for 12 of her early ancestors with surnames Campbell, Lunger, Gier, Markel, Eckert, Strahle, and Fischaess. All were residents of Washington Township.

Daniel Clinker, a resident of Albany, Ohio, received the award for 28 of his early ancestors with surnames Clinker, Reed, Mulligan, Woodcox, Markel, Gier, Sanders, Tharp, Evert, Lorah, Huff, Kuhn, Smith, Meeker, Riek, Messerly, Mehring, and Bradley, who resided in Delaware, Tiffin, Noble, Defiance and Farmer townships.

Timothy Weible, a resident of Moreno Valley, Calif.; Lynette Dunbar Weible of Lady Lake, Fla.; Aaron Weible of Defiance; Kent Dunbar of Pittsboro, Ind.; Janelle Dunbar Dillon of Danville, Ind.; and Lynda Dunbar Sheets of Wauseon; received the award for 11 of their early ancestors with surnames Rohn, Landis, Dunbar, Troeger, Thieroff and Wolfrum-- all who resided in Highland and Richland Townships.

Thelma Riehle, of Edgerton, received the award for six of her early ancestors with surnames Koerner, Fink, Riehle, Richardson, and Orr who resided in Milford and Farmer townships.

Through the First Family applications, Patricia Campbell learned she shared ancestors with both Nick Wilhelm and Dan Clinker making them her "cousins." They met for the first time at the First Family reception.

Each family presented information about their ancestors. Nick Wilhelm brought several vintage

items used by his ancestors, including a froe used to make wooden shingles. Patricia Campbell's earliest ancestor was Archibald Campbell who first resided in Washington Township in 1845. "Arched" served in the War of 1812 and his father McDonald Campbell served in the Revolutionary War.

Dan Clinker reported he is the ninth generation of Clinker's to reside in Defiance County since 1854. The first two generations to reside in Tiffin Twp. were Christian Clinker, veteran of the Revolutionary War and his son Samuel Clinker, veteran of the War of 1812. His earliest ancestor to reside in Delaware Township by the winter of 1820 was Benjamin Mulligan. Ben served as a juror on the first court in Williams County at Defiance that was held on 5 April 1824. Delaware Township later became part of Defiance County in October 1845. Daniel's ancestor Rachel Perry-Tharp's lineage can be documented back to Commodore Oliver Hazard Perry and Mayflower Pilgrim George Soule.

Janelle Dunbar Dillon reported that her earliest ancestor to reside in Richland Twp. was William Rohn in 1822 with his wife, Elizabeth Landis Rohn, and their daughter, Mary Rohn Tittle-Dunbar.

Thelma Riehle reported her earliest ancestor was Rev. Gottlieb David Koerner and wife Christiania Fink in Milford Twp. in 1859. Their daughter Mary married Adam Riehle. The Koerner-Riehle family has held a reunion for the last 89 years at the Emanuel United Methodist Church on Kramer Rd, Edgerton; however, the 2020 and 2021 reunions were via Zoom.

All generations from applicant to the ancestor must be proven with documentation. The application and payment of a onetime fee of \$15.00 must be received by 1 August 2022. Applicants are not required to reside or ever have been a resident of Defiance Co., OH. Applications are available to print on the Chapter website.



### From the December DCGS Board Meeting

Dawn Hasch moved that the chapter join the Stryker Area Council with a \$30.00 membership. Rhonda Casler seconded the motion which carried.

Dianne Kline reported that the chapter blog had 1378 hits last month and since its inception 233,922 hits.

Dawn Hasch, membership chair, noted that she is accepting dues for the 2022 year; at this time 27 members have paid.



### There Was Also "Annie Appleseed"

Students of the Old Northwest know that apples came to that territory in many ways. The crab apple is native to North America, and was already cultivated by indigenous people, before Columbus. The French missionaries brought European varieties from Canada to the Ohio Valley in the late seventeenth century: General Anthony Wayne was astonished, in his 1794 campaign against the Shawnees and Miamis in the Maumee River Valley, at the prolific groves of apple trees near native settlements. Wealthier settlers, like retired general Rufus Putnam (who led the New Englanders of the Marietta settlement) or the Virginian Thomas Worthington (one of Ohio's first US senators) brought apple cuttings from the East, with which to establish orchards on their farms. Neighbors and friends took cuttings from their trees in turn, spreading apple culture in southern Ohio.

The work of John Chapman was different from these other introductions of the apple to Ohio Territory, both in scope and type. In scope: Chapman spread his apple trees not from one, but from dozens of nurseries she planted across north-central and western Ohio, and into northeastern Indiana: hundreds, perhaps thousands, of early settlers benefited from the quick, local availability of young trees his work provided.

In type: Unlike Putnam, Worthington and the commercial orchardists who would one predominate. Chapman was not focused on apples for eating or cooking. Like the early pioneers his work served, he saw apples as an important source of self-supporting farm life. Apples fed the hogs that were most early settlers' first sourceof cash; apples pressed made vinegar, used to clean and to preserve food, as well as cider, a safer beverage than water from streams or shallow wells, or milk from expensive dairy cows. And apples dried could be added to winter cookery, when greens, fruits and vegetables were in short supply. But it seems that though his work was different, it was not entirely unique.



Canadian author Helen Humphries, in her fascinating book The Ghost Orchard (HarperCollins, 2017), tells the story of Ann Jessop, born a generation before John Chapman, in the North Carolina colony in 1738 a woman who became known as Annie Appleseed.

Chapman was raised in a large, mixed family with one sister and ten step-siblings Ann, who was widowed and remarried, headed a similar household after her second husband died, with fourteen children from the two marriages, eleven of them stepchildren.

But something must have happened during a visit to England in 1790 to draw her to apples, because she returned to North Carolina—now part of the United States—in 1793, bringing with her scions from twenty varieties of English apples (Humphries name them all), which a local orchardist grafted for her. But bringing English varietals to America—a common practice then—was not the end of Ann's story. Just as Chapman's travels were motivated

in part by his work spreading the gospel of the Church of the New Jerusalem, based on the writings of Emanuel Swedenborg, Ann traveled extensively to proselytize for her own sect, the Society of Friends, or Quakers.

"She seemed," Humphries writes, "to be away more than she was home, and her trips, even to neighboring communities, were lengthy. She also traveled regularly to Virginia, New Jersey, Ohio, Pennsylvania, Maryland, Vermont and Indiana." And it seems that wherever she went, she brought not only her faith, but also cuttings from the North Carolina orchard, spreading apple cultivation across the Upper South and Northeast. And like Chapman, she often sold her scions, the proceeds from which supported her work and travels.

Ann Jessup eventually moved to Highland County, Ohio, where she lived with one of her daughters until her death in 1822. You can find a brief biography of "Annie Appleseed" in the NCpedia, from the State Library of North Carolina, at: www.ncpedia.org/biography/jessup-ann But Helen Humphry's The Ghost Orchard tells the tale more extensively (including that list of twenty English apple varieties), and with more liveliness: highly recommended!



# Defiance County's Civil War Service Certificate: A Certificate Accorded by the Defiance County Genealogical Society

To be considered for the DCGS Civil War Service Certificate, an ancestor must be proven to have served in a Defiance County, Ohio military unit during the Civil War or have been a Civil War veteran (either Union or Confederate) who was born, lived, died or was buried in Defiance County, Ohio. The applicant must be a member of the Defiance County Genealogical Society for this certificate to be awarded.

The applicant filing for a Defiance County Civil War Service Certificate must include documentation for the ancestor for one of the above events (service, birth, residency, death, burial) occurring in Defiance County, Ohio. In addition the applicant must include proof of the unit with which the Civil War soldier served. The application must also include either a generational chart or a written explanation showing the relationship of the applicant with the ancestor who is the focus of the application. The applicant may be a direct or collateral descendant of the Civil War ancestor.

You may submit as many applications as you wish. Also you may include a story or biography of your ancestor for possible use in the chapter newsletter, website, or future publications. If you submit an article, please date and sign the submission and note that the chapter has permission to use the article.
